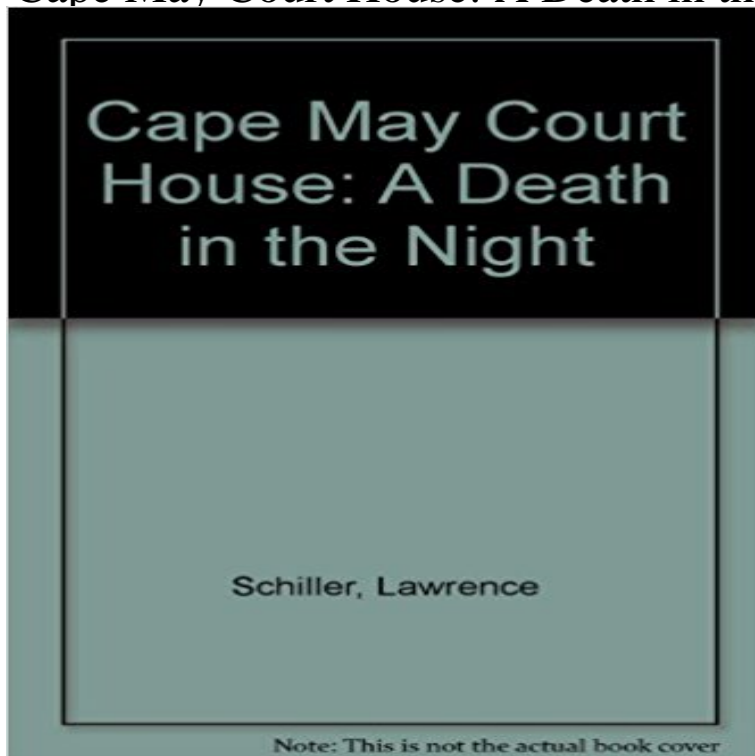


## Cape May Court House: A Death in the Night
