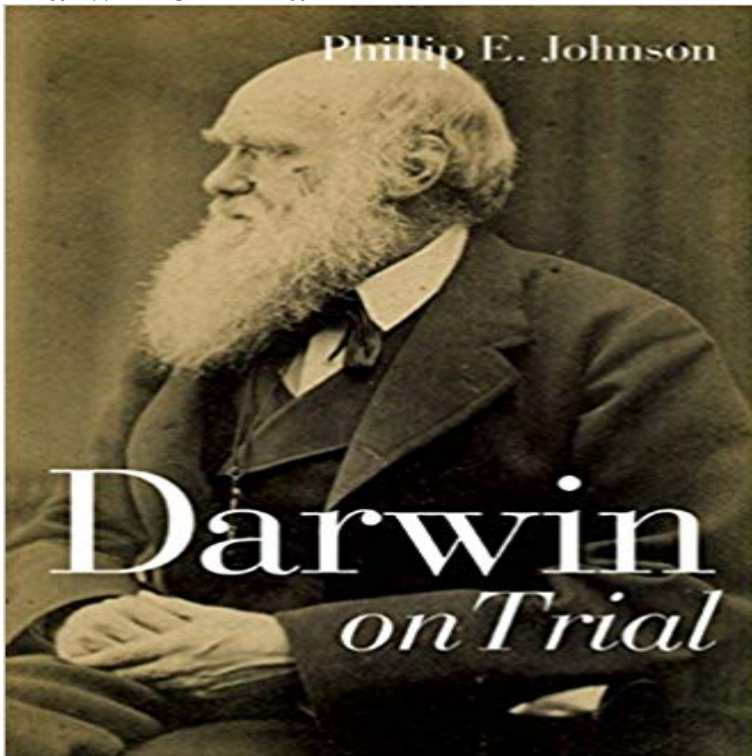


Darwin on Trial
