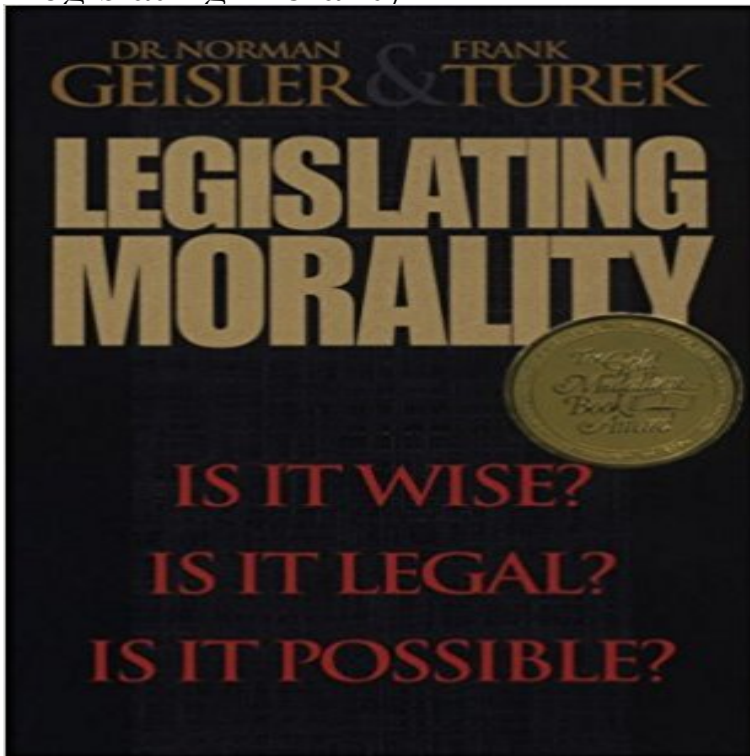


## Legislating Morality
