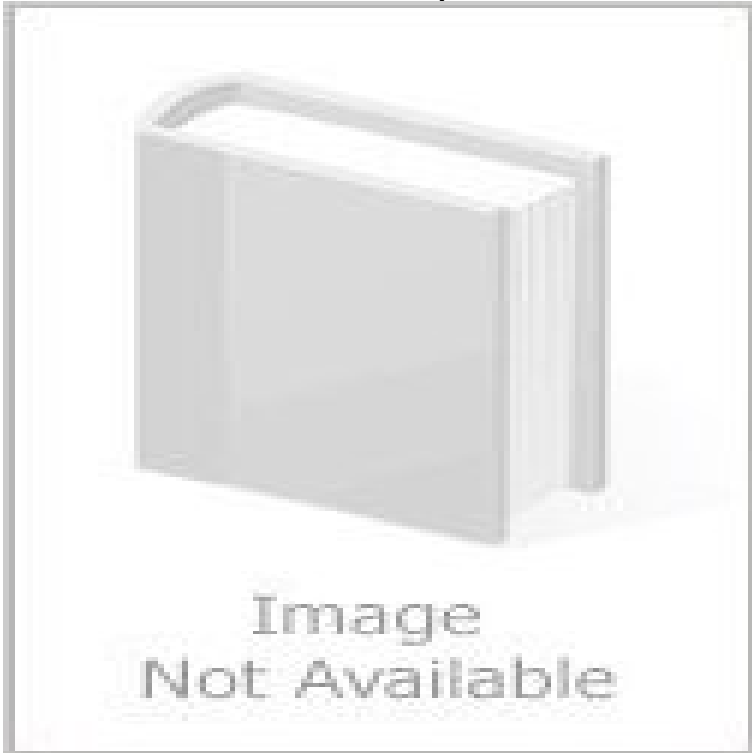


Education of the Exceptional Child
