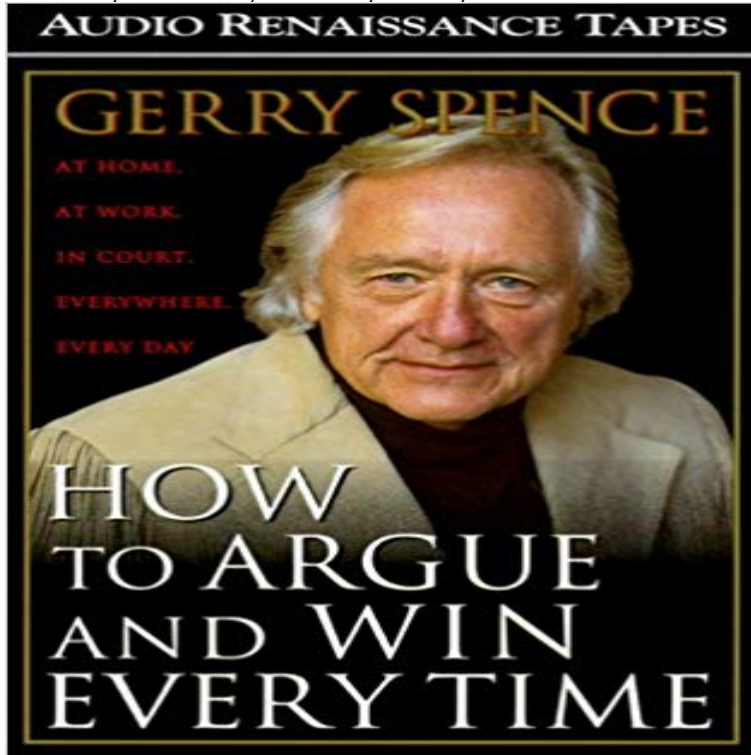


# How to Argue and Win Every Time: At Home, at Work, in Court, Everywhere, Every Day
