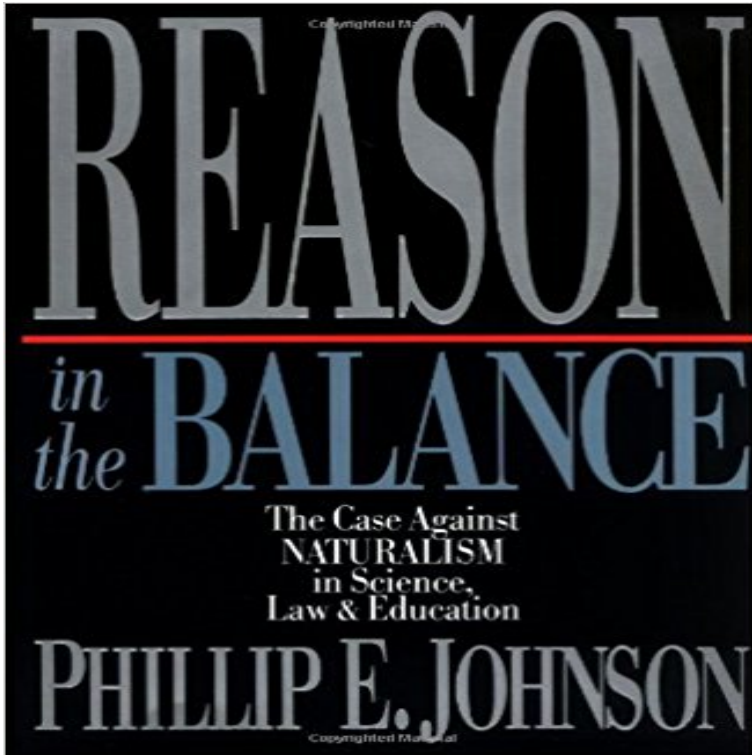


## Reason in the Balance: The Case Against Naturalism in Science, Law & Education

And he argues that naturalism has even infiltrated the church--marginalizing opposition as irrational, and encouraging Christians to adopt a more reasonable stance. In *Reason in the Balance*, Johnson writes energetically and persuasively--chapter by chapter zeroing in on the chinks in the argument for naturalism. He explores nearly every acre of today's cultural battlefield: God, sex education, evolution, abortion, cosmology and particle physics, what our public schools should teach, the basis of law, the meaning of reason and a few other things that matter. Armed with biblical truth, common sense and a clear understanding of his foe, he steps out like David to fell the intellectual Goliath of our day.
