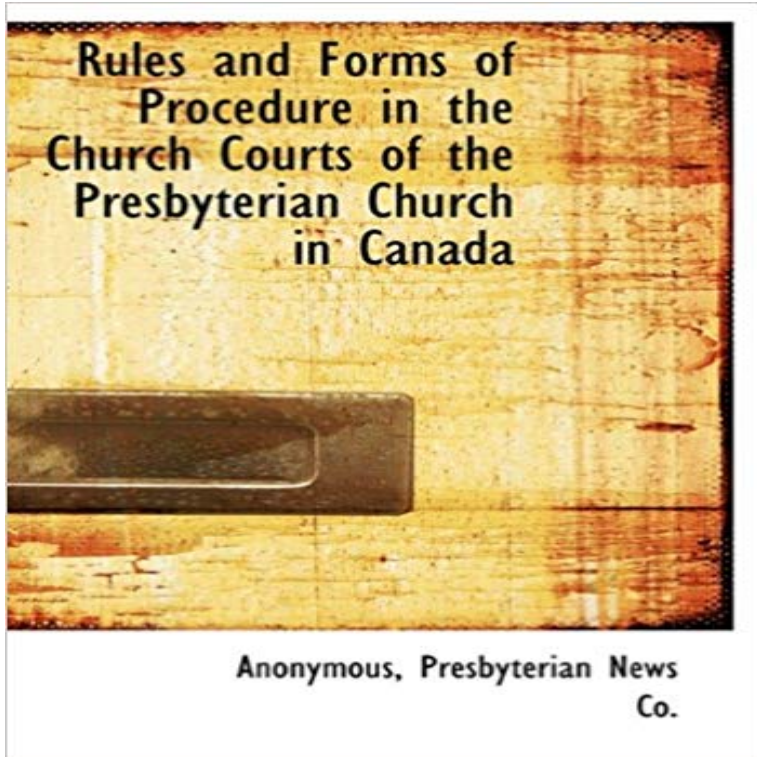


# Rules and Forms of Procedure in the Church Courts of the Presbyterian Church in Canada
