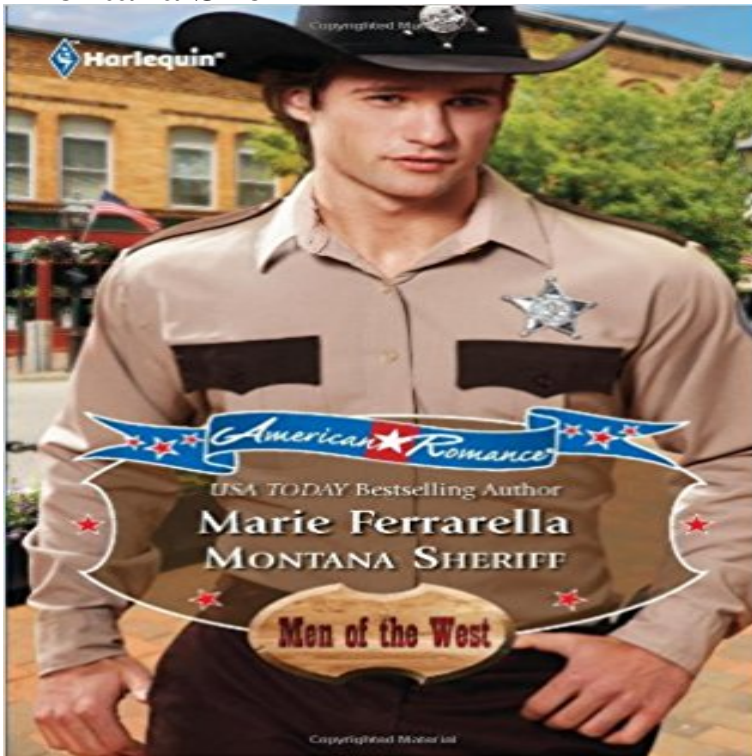


## Montana Sheriff
