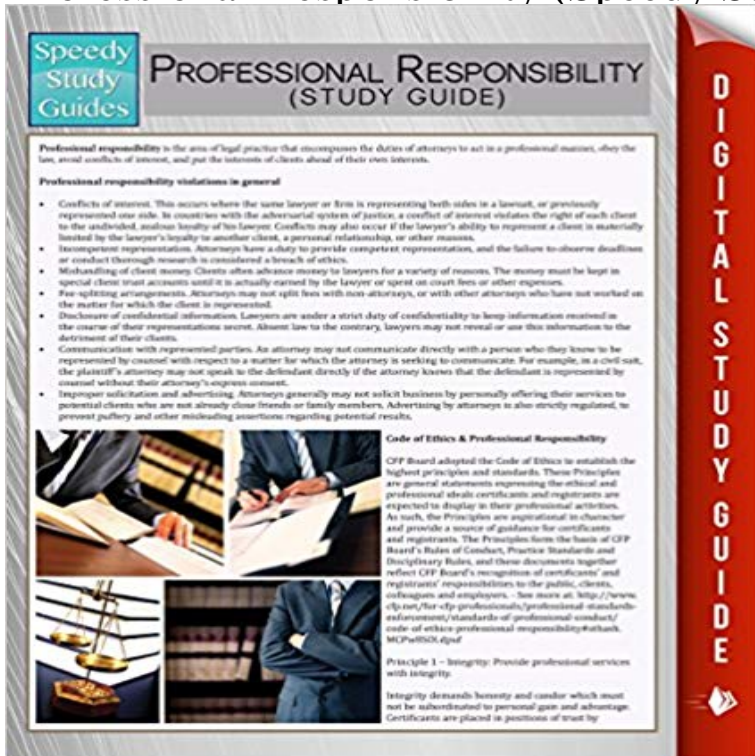


# Professional Responsibility (Speedy Study Guide)
