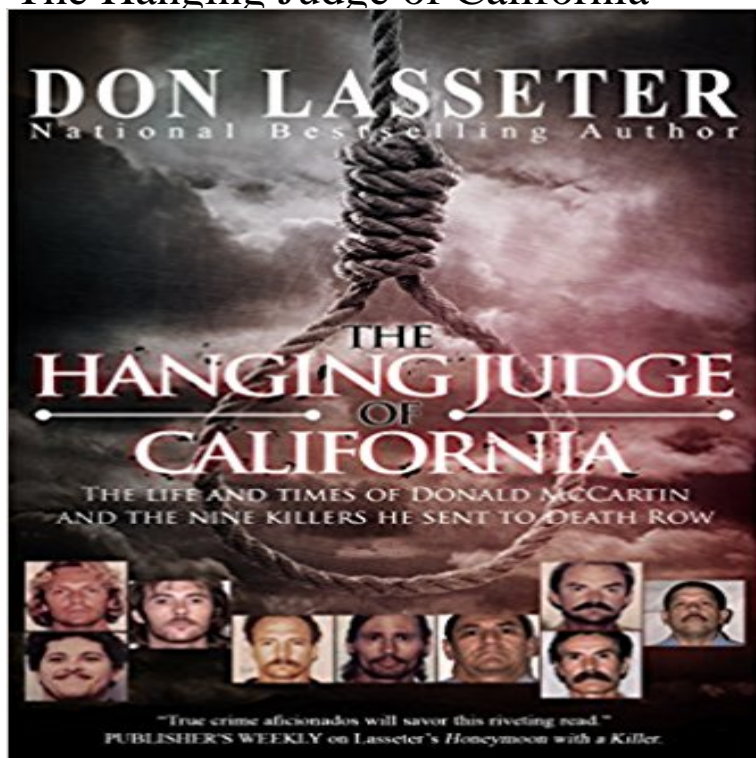


The Hanging Judge of California
