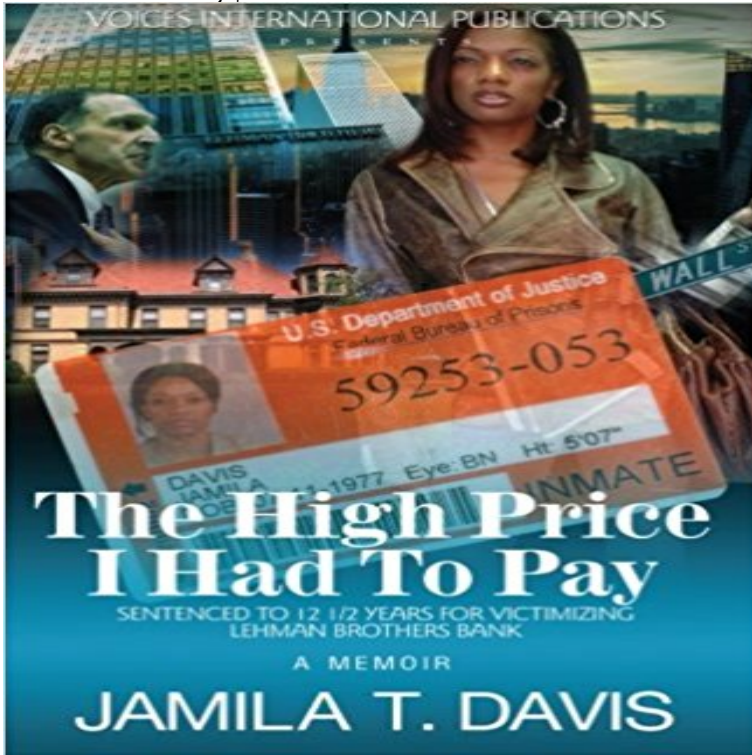


The High Price I Had To Pay: Sentenced To 12 1/2 Years For Victimizing Lehman Brothers Bank
