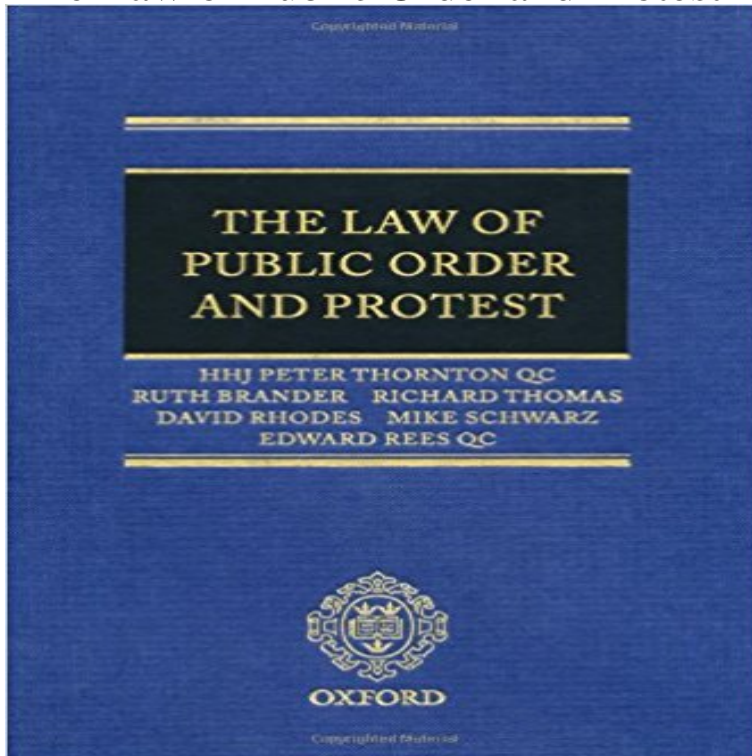


# The Law of Public Order and Protest
