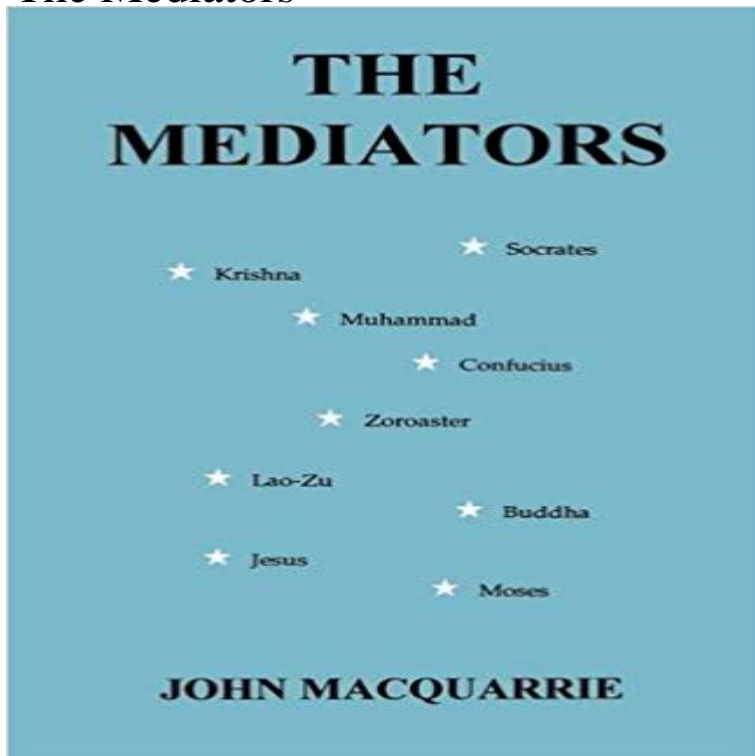


## The Mediators
