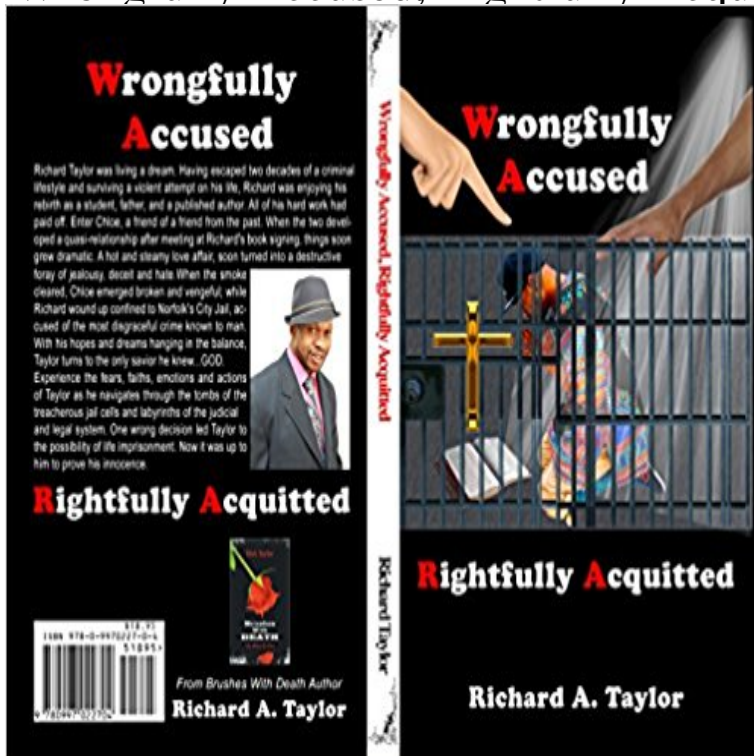


## Wrongfully Accused, Rightfully Acquitted
